Deirdre McDermott is an architect, planner and urbanist working in private practice and is a member and former president of ICOMOS Ireland. She has campaigned for and since its establishment in 2015, has served as one of the six elected ACOs driving the work of ADCOM, initially as VP and subsequently as ACO.

During that time, together with Bureau members, she has led the establishment of the *Review and Facilitation Committee*, (RFC) working closely with the Secretariat on the health of NCs and encouraging the activities of ADCOM; has written the ToR for and is driving the *Sustainability and Communications Task Force (SCTF)*; has established the *Assisting Adcom Volunteer* (AAV) programme and is currently the ACO focal point for the *Scientific Symposium21 on Living Heritage and Climate Change*.

Career Profile

Deirdre is a registered architect, a qualified planner and urban designer and principal in Deirdre McDermott and Associates. Currently based in Co Galway, Ireland, she has worked principally in Ireland, the UK, Africa and France. She has worked extensively in area based regeneration, urban design and conservation in Ireland, France and the UK and recent work includes a series of collaborative projects in small towns and villages and restoration and conversion projects on traditional buildings in France, designed to reintroduce sympathetic economic activity in small villages on the mediterranean fringe, as well as a range of conservation projects in Ireland. She has worked with a number of major private and public clients on regeneration and mixed use development projects where the focus has been on integrating new development into existing towns and cities. The practice completed the National Inventory of Architectural Heritage for the North Georgian City of Dublin.

She completed a Diploma in Architecture and a Masters in Urban Design with a double distinction in Oxford, undertook the RIAI Conservation Accreditation Grade III and in 2011 completed the MUBC in UCD.

Deirdre served for six years as a member of the Historic Buildings Council, an advisory body to the Environmental Heritage Service in Northern Ireland, reviewing their First and Second (Listed Buildings) Survey.

She was a co-opted member to an advisory body established by the Irish government to develop policy on architecture and on the architectural heritage in State Care (Action on Architecture 2002 – 2005)' which preceded and recommended the establishment of the conservation accreditation system within the Royal Institute of Architects of Ireland. She was President of the Irish national Committee of ICOMOS for six years, Founder member and secretary of the Irish National Committee of the Blue Shield, vice President, then elected officer of ICOMOS Advisory Committee and is currently ICOMOS Ireland representative to the government's Climate Change Adaptation Sectoral Plan for Built and Archaeological Heritage Stakeholders Group. She is currently on the Board of the Heritage Council and a member of:

As elected AdCom Officer, working with my fellow elected officers, and colleagues in the OCD | RBA, SDG and Climate Change working groups, I have developed a keen understanding of the organisation and its operation, identifying gaps as well as strengths.

My ambition is to use the final term of my eligibility as ACO, to progress the work of the *SCTF* and under the three strands of *Sustainability, Communications and Memory* to review the way we do our work, and help deliver an organisation which has transitioned to a more inclusive and sustainable format.
