Electoral platform statement

ICOMOS' strength comes from the knowledge that each member is willing and able to share with others. That knowledge stems from the experience of professionals but it also comes from being open to a diversity of world views, cultural expressions, professional methods, and generational perspectives. Our credibility depends on our inclusivity and our ability to provide meaningful guidance that reflects that diversity.

For ICOMOS to fully take advantage of its strength, it needs to rely on its ISCs and NCs with greater confidence. This is particularly critical for national committees that are both the mechanism to put into action ICOMOS' work and more substantially the mechanism to reflect the diversity of cultural experiences around the world.

Inclusivity is everyone's responsibility. My own contribution in seeking the Presidency of the Advisory Committee is to help build the mechanisms to take on the challenge of diversity that ICOMOS needs to succeed. Beyond improving communication, we need to lean on the leadership of national committees to include more voices in our conversations and to maintain their authenticity including by encouraging the use of more languages. We need to trust national committees to identify the best ways for that diversity to contribute to our work. I hope to work with my fellow members to create a roadmap to define the ways for knowledge to be shared with impact, to establish the presence of national committees and scientific committees at the heart of ICOMOS' work, and to support our organization in being open to the many perspectives the world has to offer. We can continue our work with relevance and impact if we take full advantage of every part of our organization.
